RETURNING STUDENT ENROLLMENT CONTRACT FOR THE 2020 -2021 ACADEMIC YEAR

TUITION AND FEES

Trinity Catholic High School's tuition for the 2020-2021 academic year will be \$15,200. We offer three payment plan options. By checking one, you agree to pay the school's tuition according to the selected plan.

DEPOSIT AND CONTRACT

A non-refundable registration fee of \$250 per student (includes the \$50 per family HSA fee) and the signed tuition enrollment contract are due on or before January 24, 2020, in order to guarantee the student's placement in Trinity Catholic High School for the 2020-2021 academic year.

This year, we are offering an early bird discount for the registration fee:

- all paperwork postmarked or submitted electronically by January 6th, the registration fee is \$150 per child
- paperwork postmarked or submitted electronically between January 7th and 24th, the registration fee is \$250 per child
- paperwork postmarked or submitted electronically after January 24th, the registration fee is \$350 per child

PLEASE SELECT ONE PLAN

- Plan (1) Tuition to be paid **in full** by July 1, 2020.
If paid by cash or check:
 - Early payment discount of 4% if paid by May 15th
 - Early payment discount of 2% if paid between May 16th and May 31st
 - Early payment discount of 1% if paid between June 1st and June 30th
If paid by credit card:
 - Early payment discount of 2% if paid by May 15th
 - Early payment discount of 1% if paid between May 16th and May 31st
 - Early payment discount of .5% if paid between June 1st and June 30th
- Plan (2) Tuition to be paid in **two (2)** installments. Due July 2, 2020 and January 1, 2021. No discount applied.
- Plan (3) Tuition to be paid in **eleven (11)** installments. Due July 2020 – May 2021 through SMART Tuition payment plan.

Parents of new students must go to the Trinity Catholic website, www.trinitycatholic.org, by May 15th and sign up for SMART (our school code is 12711). You will find the enrollment form under the admissions tab, tuition payment online. You do not need to enter a student id number, we do not use them. You may choose to pay either the 1st or the 15th of the month, by invoice, ACH or credit card.

Sibling discount: \$1,000 1st sibling / \$1,500 2nd sibling

Please note: Financial Aid and Academic Scholarships are deducted from the final tuition prior to applying the early payment discount.

ACCOUNT STATUS

By signing this contract, you understand and agree that:

- Accounts are considered past due after 30 days. Students can be asked to withdraw if the tuition account becomes past due.
- Your account will be kept current. Your tuition obligation is your responsibility and is unconditional.
- Your financial obligations to the school must be met before the student will be permitted to advance to the next academic year or, if a senior, graduate from Trinity Catholic High School.
- Trinity Catholic High School will not release report cards or grades, and transcripts will not be sent to other schools or colleges, until your account is brought up to date.
- The student/students will not be allowed to participate in any athletic program, extra-curricular program or school-sponsored trip unless your account is current.
- Financial aid awards can be rescinded if your tuition account is not kept current.
- Your registration fee will be refund only in the event you have not received sufficient financial aid.

PENALTIES

If your account is overdue on:

- August 20th: the student will not be allowed to begin classes in the new academic year
- January 10th: the student will not be allowed to take mid-term exams or begin second semester classes
- May 1st: the student will not be allowed to take final exams. Seniors will not be allowed to graduate or participate in graduation exercises or have transcripts sent out until the account is paid in full.

By signing this document, you understand and accept the terms and agreement as stated in this contract and accept full, unconditional responsibility for the payment of all tuition and fees assessed.
